I would like to thank our Condominium Board Members **who generously volunteer their time without compensation.** Their dedication to overseeing finances, maintenance, rules enforcement, and the long-term care of our community helps protect our safety, property values, and quality of life. On behalf of all residents, thank you for your continued service.

Community Updates

- Resurfacing Project: Begins May 1 through mid-June. No reserved parking during this time. Do not park in barricaded areas. 5300 M&M Corporation will post temporary parking schedules. If leaving your vehicle on property, please leave a key at the Clubhouse Office in case it must be moved.
- Pool House Repairs: Structural, roof, drywall, and gutter repairs (ABCD, EFGH, IJKL, MNOP, and RST) are underway.
- Clubhouse Office: Upgrades in progress by Maintenance.
- Lighting & Electrical: Common area post lights are being upgraded to LED. Receptacles are being replaced with GFCI outlets to meet inspection requirements.
- Garbage Rooms: All have been power washed and painted.

Events & New Business

Thank you to the Social Committees and BHC for organizing community events. We encourage resident participation.

The 2026 By-Law and Management Committee will review current By-Laws, proposed amendments, and further develop 5300 M&M Corporation. Six corporations are currently managed by outside companies.

Due to rising costs, the resident van service has been discontinued. Alternative transportation options are being explored.

Officer Grotenhaus stated please be aware of surroundings. No other problems were discussed.

AGENDA

Meeting opened at 7:11pm by President R. Levine, followed by a salute to the flag and a moment of silence. Quorum established with 19 officers present in person and via zoom.

January 2026 meeting minutes were read, no corrections were made, motion made by I. Ortiz to accept as read, motion seconded and passed.

Treasurer's report given by M. Nolan. Delinquencies were \$23,452.27. Motion made by J. Bader to accept as presented, motion seconded and motion passed.

CLUB REPORTS: Social Club-C. Rodriguez spoke about the Valentines Day party to be held February 14 at the clubhouse from 6-9pm. Bingo continues every Wednesday at 7pm, Card Bingo will be on hold for night. LCR every 2nd n 4th Friday at 1pm in the clubhouse.

OLD BUSINESS: still asking for owners' email addresses. Pavement project will be starting in early May and should take about 5-6 weeks. We are currently awaiting bids for pool house restoration project.

NEW BUSINESS: 5300 M&M nomination from the floor. Three positions open, President, Treasurer & 2nd VP. There were no nominations for President and Treasurer, officers retain their positions. Two nominations for 1st VP, C. Hubbard and C. Rodriguez. Both candidates accepted the nominations. Elections will be held February 5, 2026, at 7pm in the BH Clubhouse. Discussion on the crown (aka, rack of lamb) for the west wall. Motion made by J. Baader to reserve \$100,000.00 from Comcast bonus to set aside for west wall restoration. Motion seconded and passed. Vote taken with 19 officers voting yes and 2 officers voting no. Annual audit is currently being completed. We will be hosting a officer's board certification class, March 26th from 10am-3:30pm in the clubhouse. The class will be given by a state representative and is mandatory for all officers within a 90 day period of election or appointment. We will have a ½ hour lunch break from 12:00 -12:30, please bring your own lunch. Assistant City Manager Adam Richman will be here March 19th from 6-8pm to explain the upcoming ballot incitive regarding elimination of property taxes. Please plan to attend. This amendment will be on our election ballots in November.

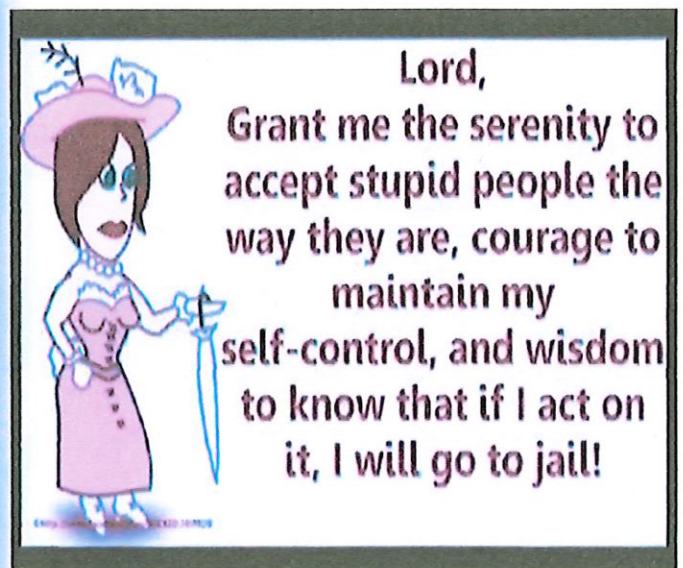

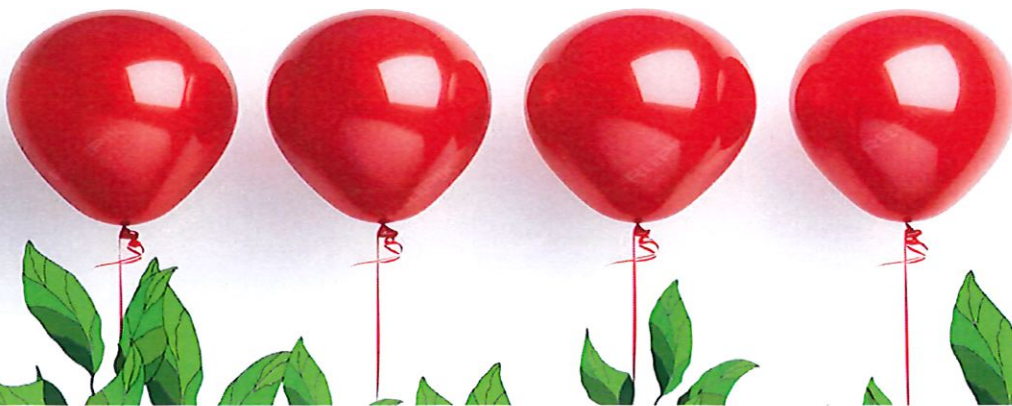

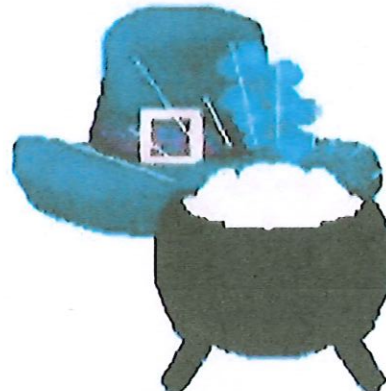
